MATH PLACEMENT PROJECT GRANT

The **Math Placement Project Grant** is managed by SBCTC and generously funded by College Spark Washington. Washington community and technical colleges continue to work towards more equitable placement practices.

Key Focus includes moving away from standardized testing and focusing on high school transcripts evaluation and implementing guided self-placement models designed for students to reflect on prior experiences with reading, writing and math. Although colleges have made significant strides in placement assessment, inequities still exist, especially for historically underserved student populations and BIPOC students.

The **purpose** of this project is to create a cohort of colleges who are willing to share and learn from each other as they invest in examining and revising their current practices to ensure that all students who are currently eligible for placement into college level courses are being enrolled into those courses. Additionally, this work should support colleges in moving forward towards common practices that are consistent and transparent for students.

SB 5582 NURSING CAPACITY EXPANSION WORKGROUP UPDATE

Guiding Legislation

SB 5582 requires that the college system submit a plan for CTCs to train more LPNs and RNs in the next four years, especially in shortage areas like rural communities. Per legislation, we're required to consult with health care employers, local workforce development councils, and exclusive bargaining representatives of nursing professions.

Staffing/Coordinatioin/Stakeholders

SBCTC staff and a contractor hired for this work are guided by a group of 5 nursing program directors and one faculty member.

Progress

As of July, we've completed Phase I of the project, which included literature review, analysis of existing data, interviews with over 20 nursing program directors, consultations with the Washington State Hospital Association (WSHA), Washington Center for Nursing, Washington Workforce Development Association (WWA), Association of Washington Business (AWB), Washington State Nurses Association (WSNA), and other stakeholders. We've also administered a student survey and received over 200 responses from 16 colleges. Phase II will focus on compiling the report, prioritizing themes and aligning on recommended solutions.

Background

CTC nursing programs produce over 60% of our state's pre-licensure nurses. Since 2019, legislative investments have enabled significant program growth. In 2017/18 academic year, CTC admitted 1830 (1731 pre-licensure) students. In 22/23 they admitted 2523 (2337 pre-licensure), an increase of 693 or a 40% growth. Even though programs have successfully weathered the pandemic and managed to grow, there are known barriers to expansion. Clinical capacity/clinical placements remain at the top of the list, followed by ability to recruit and retain instructors and administrators, regulatory burdens, and physical capacity (lab/classroom space).

A separate workgroup (Washington Center for Nursing's Clinical Placement Initiative) is addressing clinical placement shortages, aiming for solutions by summer 2025. As such, our workgroup excluded clinicals and focused on areas of improvement within the colleges' purview that can be achieved within the short 4-year window.

Themes

(Note: Prioritization is pending)

Theme 1: Student Supports

Finances:

- Students identify finances as a major barrier to their success, and as a reason they are working while
 in school.
- Early Achievers Grant-like model for nursing, where a designated point of contact serves as a
 resource to students, helping align financial and other supports, leading to no or low-cost
 educational opportunities for participants may prove beneficial to student success.

Advising:

• Nursing-specific advising and tutoring will help students get into and through their programs. Some colleges have already carved out funds/created partnerships to address this need.

Integrated Instructional Delivery:

 As students enrolling in nursing programs have increasingly varied linguistic backgrounds, varied levels of preparation (many have retaken their pre-requisite courses multiple times to achieve a high enough grade), and experienced learning setbacks during COVID, I-BEST is being successfully deployed by a small number of programs.

Theme 2: Regulatory Challenges

NCLEX pass rate requirement:

- At least 80% of nursing students must pass the NCLEX on the 1st try. Programs identified this as overly restrictive. Most accrediting bodies do not require such a high bar.
- The requirement impacts admissions processes, and the resources and time that go into preparing students for the test at many CTCs.
- It impacts program design and hinders innovation as colleges are reluctant to take risks and try out new educational modalities, such as apprenticeships or remote/hybrid instruction.

Bachelor of Science 4-year program:

- Most students pursuing BSN-level education in our system have a prolonged and fragmented path, compared to nursing students in 4-year institutions.
- Most CTC nursing students complete a full year if going full-time of pre-requisites prior to being admitted into a 2-year ADN program.
- Achieving a BSN adds two more years (5 years total), frequently at a different campus.
- The majority of respondents to the student survey identified existing campus/cohort support systems
 as integral to their ability to succeed in the program; starting a program at a new campus is a
 deterrent to continuing their education.

Theme 3: Faculty & Program Administrators

Programs that received legislative funding stated that the resources improved their ability to retain and hire staff. Enrollments have increased across CTC nursing programs since the investment was made. The number of reported FT vacancies in the CTC system peaked in 2018/19 (pre-investment) at 46 and was down to 17 in 2022/23. Total FT employment also grew from 185 in 2018/19 to 297 in 2022/23. Total number of faculty (PT and FT) increased from 482 in 2018/19 to 710 in 2022/23.

Faculty Funding:

• As programs have grown, available resource no longer has the same impact. Programs worry that they will not be able to sustain this growth.

Faculty Onboarding:

• Faculty transitioning from industry do not have adequate support in their professional development as educators.

Director Turnover:

- The nursing program director's job is complicated and can take years to learn. There is no formal onboarding process and most directors comment on having relied on a volunteer mentor to help.
- While turnover at the director's level cannot be tied directly to enrollments, the turnover and lengthy time needed to learn the ropes can reduce opportunities for program growth and innovation.

Theme 4: Space Limitations

A number of directors identified limited physical space on campus as hindering program expansion. This challenge was identified more frequently by technical colleges which may be negatively impacted by facilities funding distribution formulas.

Theme 5: Programmatic Challenges

SIM Support:

- Equipment doesn't usually come with resources for SIM staff, SIM Staff development, technical support.
- SIM is only effective when adequately supported.
- Taking advantage of the new simulations rules to increase students' clinical opportunities requires
 qualified staff and resources for ongoing professional development.

Theme 6: Pre-Requisites

Students really struggle with pre-reqs and admissions processes. Many directors point to the process of obtaining pre-reqs as a challenge for nursing students. While directors acknowledge this as an issue, there is no consensus on whether pre-reqs should align across all CTCs.

SBCTC STAFFING UPDATES

- Student Services reorganization
 - Jamie Traugott, Director of Student Services and K12 Alignment, has absorbed the majority of the student services portfolio. She will also continue to provide leadership and oversight of dual credit work.
 - Stephanie Rock, program administrator of dual credit and strategic enrollment initiatives, will assume a policy associate position and be the point person for the dual credit/strategic enrollment areas, and continue to report to Jamie.
 - Jennifer Dellinger, policy associate in student support programs (BFET, WorkFirst, etc.) and her team will move under Marie Bruin, director of workforce education.
- New Policy Associate Bachelor's Degree Programs
 - Ken Hang, formerly faculty at Green River, is joining the SBCTC Aug 1. Ken will lead
 the continued BS/CS work as well as overall bachelor's program work. He will also
 serve as the lead for ACPL.





LATEST ENROLLMENT TRENDS

- \bullet Overall enrollments are continuing to rebound! Spring 2024 up 7 % overall compared to Spring 2023
 - 7% increase in state funded
 - 8% increase in contract-funded enrollments 11% decrease in student-funded enrollments
 - Applied Baccalaureate up 7% (+276 FTES)
 - Basic Education for Adults up 7% (+946 FTES)
 - IBEST up 27% (+637 FTES)
 - Running Start up 18% (+3,501 FTES)
- 2023-24 enrollments are up a total of 8% compared with the prior academic year.



OPERATING BUDGET REQUESTS

- <u>Competitive Compensation</u>—Increase salaries for all employee groups, supported with 100% state funding. Colleges are struggling to recruit and retain faculty and staff in several areas. Recent salary increases from the legislature created equity gaps as some groups received significantly larger increases than others. These challenges cannot be address unless our college system received compensation funding to help keep pace with industry and K-12.
- <u>Increase General Purpose Funding</u>—With the rising cost of doing business throughout all areas of campus operations, colleges are stretched to meet demand using existing resources. While individual campus needs may differ, all colleges are squeezed by cost increases, restricted funding and structural barriers that limit colleges' ability to respond to student and college operating needs.
- Expand Capacity of Job Skills Programs—Last biennium the program enabled colleges to provide 1200 customized skills courses to 8200 working learners across 118 JSP grants. Demand exceeds available funding, and expansion would provide opportunity to expand college participation to meet current demands and increase the number of small businesses supported with training grants. (\$7.25 mil/year currently)





CAPITAL BUDGET REQUEST

- In April, WACTC voted to approve recommendations as follows:
 - Prioritizes minor projects before major projects
 - \$1M for Grays Harbor College Lake Swano Dam planning assistance
 - Prioritizes major projects in the priority order that they were added to pipeline
 - Targets an estimated request level of approximately \$600M
 - Includes major projects that fall beyond funding target in future biennia of 10 year capital plan
 - Has State Board staff work with colleges to update cost estimates re: inflation, fee rates, laws, requirements and current sales tax rates
 - Increase minor works from \$2 mil to \$5 mil
