Introduction

The Image/Upgrade Overview Document is intended to provide ctcLink users with a summary of the changes that will be made in the system as a result of the upcoming image or PeopleTools upgrade implementation. Oracle releases multiple PeopleSoft updates, called images, for each pillar every year. Each Image contains bug fixes and features that are important for PeopleSoft to work well. PeopleTools upgrades update the underlying framework of the system. There are minimal changes that are noticeable to the end users. Below is an overview of the changes that you can expect to see as part of this upgrade.

Payroll

Updated Federal / State Tax Table

Federal (State = \$U) - A new table entry effective-dated 01/01/2025 includes the increase in the Social Security taxable wage base from \$168,600 to \$176,100 for 2025. The Social Security tax rate on wages and tips remains unchanged at 6.2% for both employees and employers for 2025. <u>https://www.ssa.gov/oact/cola/cbb.html</u>

Note: U.S. Federal withholding tax changes for wages paid on or after 01 January 2025 had not yet been published in time for delivery in Tax Update 24-D.

Once published, the 2025 U.S. Federal withholding tax changes will be delivered in Tax Update 25-A.

Arizona (AZ) - A new table entry effective-dated 01/01/2025 is delivered with the Arizona state minimum wage increase from \$14.35 to \$14.70 per hour. <u>https://www.azica.gov/labor-department</u>

California (CA) - A new table entry effective-dated 01/01/2025 is delivered with the California State Disability Insurance employee tax rate increase from 0.011000 to 0.012000. https://edd.ca.gov/en/payroll_taxes/tax-rated-employers

Connecticut (CT) - A new table entry effective-dated 01/01/2025 is delivered with the Connecticut state minimum wage increase from \$15.69 to \$16.35 per hour. <u>https://portal.ct.gov/governor/news/press-releases/2024/09-2024/governor-lamont-announces-minimum-wage-will-increase-in-2025?language=en_US</u>

Iowa (IA) - A new table entry effective-dated 01/01/2025 is delivered with Iowa state unemployment taxable wage base increase from \$38,200 to \$39,500 for 2025. <u>https://workforce.iowa.gov/employers/unemployment-insurance/employer-handbook/unemployment-insurance-taxes</u>

Minnesota (MN) - A new table entry effective-dated 01/01/2025 is delivered with the Minnesota state minimum wage increase from \$10.85 to \$11.13 per hour. https://www.dli.mn.gov/minwage#:~:text=1%2C%202023,for%20other%20state%20minimum%20 wages

Missouri (MO) - A new table entry effective-dated 01/01/2025 is delivered with Missouri state unemployment taxable wage base decrease from \$10,000 to \$9,500 for 2025. <u>https://labor.mo.gov/des/employers/tax-rates</u> **Montana (MT)** - A new table entry effective-dated 01/01/2025 is delivered with the Montana state minimum wage increase from \$10.30 to \$10.55 per hour. <u>https://erd.dli.mt.gov/labor-standards/wage-and-hour-payment-act/state-minimum-wage</u>

Iowa Withholding Lock-In Letter

Tax Update 24-D modifies the respective processes and the Tax Data Component Interface to support the Iowa withholding lock-in letter functionality by adding three new fields to the Lock-In Letter Details section of the Iowa State Tax Data page.

Prior to the modifications, the dollar amount specified in Total Allowances could not be limited.

Montana Withholding Tax

The Pay calculation processes have been updated to correctly round Montana withholding tax up to the nearest dollar in compliance with the Montana Withholding Tax Tables as published by the Montana Department of Revenue. <u>https://mtrevenue.gov/wp-</u> <u>content/uploads/dlm_uploads/2023/11/Employer_and_Information_Agent_Guide.pdf</u>

Prior to the modifications, Montana withholding tax was rounded using standard rounding rules.
