STEP 1: IDENTIFY BUSINESS PRACTICE

For example:

- Is your college hiring employees who will work from States other than Washington?
- Determine how you will be kept aware that an employee has been hired and/or moved to a state other than Washington
 - Employee notifies HR and then HR notifies Payroll, or does the employee update their home address in Employee Self-Service and Payroll is monitoring?





STEP 2: IDENTIFY EMPLOYEES WORKING OUTSIDE OF WASHINGTON STATE

Run Queries:

- QHC_HR_EMPLOYEE_ADDRESSES
 - This query will identify the employees residing and likely working outside of the State of Washington.
 - Filter the query by State and Address Type to find at least one row for each employee.
 - OFM requires us to have one row with an address type of HOME





STEP 2: IDENTIFY CONTINUED

- QHC_HR_EMPLOYEE_ADDRESSES_PY
 - This query will provide details regarding the tax location code from Job Data and Tax Distribution Status related to local taxes that apply to that state.
- QHC_HR_EMPL_STATE_ADDR_CHANGE
 - Offers an "As of Date" parameter that allows you to check if there are any address changes as of a particular date





STEP 3: REGISTER WITH STATE AGENCIES WHERE AN O-O-S WORKER IS EMPLOYED

STEP 4: SET UP CTCLINK – GLOBAL LEVEL

Accounts Payables Integration

- Vendor data for tax collectors (Finance system)
- AP State Tax Types tax classes: Withholding; UI; PFML
- AP Local Tax Types link a tax type to the local tax authority and the applicable set of tax classes.





STEP 5: SET UP CTCLINK - COLLEGE LEVEL

College-specific configuration - must be done before entering any state and local tax information for the employees

- Set up the Company State Tax Table
 - State Withholding
 - State Unemployment
 - GL Accounts
 - PFML (Other Programs) if applicable
- GL Tax Account Mapping
- Set up the Company Local Tax Table if applicable





STEP 6: SET UP CTCLINK - EMPLOYEE LEVEL

Employee-specific configuration - must be done before creating paysheets for processing through payroll

- Tax Location set up in Job Data, Payroll all active job records
- Employee Tax Information
 - State Tax Data Resident; UI Jurisdiction; Exempt from SUT
 - Other Programs applies to PFML
 - Local Tax Data if applicable, enter locality.
- Employee Tax Distribution for each job record, set state (and locality) percent of distribution.
