The Student Services & Instructional Building (SSIB) is a replacement for our current student services building. In addition to replacing obsolescent space, it will consolidate student service programs that are dispersed among other buildings on campus, and provide instructional space for a culinary arts/hospitality program.

Project Status:

Closeout procedures for the building, including punch list and administrative work are currently ongoing, substantial completion was achieved 3/5/2024. There are currently 3 outstanding COPs under dispute, which if paid as presented by the GC, may result in exceeding the project budget.

GHC is working with DES to resolve the outstanding disputes. The subcontractor responsible for all 3 of the COPs did not agree to a negotiated settlement. Mediation is scheduled for February 2025.

Delays and disputed COPs are both the result of a permit delay in March 2022.
