A major structural failure on a 3-story truss was discovered in Fall 2022. Emergency repairs followed and additional structural (Include a brief summary of the project and the investigations found more design and construction issues related to both gravity load and seismic integrity. Building occupants were relocated to other areas on campus until construction is completed. The 70,000 square foot building houses campus Library & e-Learning, Associated Student Body space, Campus Tutoring, Trio-support, Computer Networking program, Business Computing

Since the June 2024 status update, the GCCM contract and Negotiated MACC were completed in late November. All scopes have been bid and are being reviewed for overall budget tracking. The construction site around the building has been secured and separated from key campus pedestrian and vehicle movements for safety while campus continues to operate around the worksite. Additional material staging areas have been secured on nearby parking areas to prepare for steel and structural material deliveries. Interior and exterior demolition work is completed or prepped for completion pending work sequence and building envelope/weather protection. Steel and Brace Frame shop drawings are complete and items are scheduled for production with deliveries of key Brace Frames planned for March 2025. Interior micro-pile equipment is on-site and in use related to the foundation work. Additional design work is underway for gusset plate repairs that were added to scope of work in the Fall of 2024. Steel material fabrication and delivery are still being monitored as potential impacts to schedule and budget.
