### **1:30 – 2:00pm Report on ARC Executive Team IDI/ICS**

The team used assessment tools to measure where we were individually and as a team, in the work of Intercultural Development Inventory (IDI) and Intercultural Conflict Style (ICS). SBCTC is going to work on this to appear upon enrolling in courses, once all the colleges are deployed.

How do you track sex offenders possibly enrolling in classes on your campus?

By law, offenders are supposed to report to the college. Students are required to self-disclose

Pros/Cons National Student Clearinghouse v Parchment for transcript processing?

Both have been approved through shared governance committee to be connected to ctcLink. SBCTC is waiting for all schools to go-live.

Parchment is nice because it has Diploma Send (digital diploma too)

### **2:45 – 3:05pm Christine McMullin – SBCTC**

Legislative Cycle Updates – Anti-Hazing Bill, have already started with a work group. How can we prevent these travesties from happening on campuses. Financial Aid Outreach Pilot Program, 4 ctc’s as a

pilot, but could see this being sustained across the entire state in years to come. Designed for the districts with the lowest FAFSA rates. Supporting Students Experiencing Homelessness (SSEH) Pilot, went very well, that this year that SBCTC was able to secure funding for all 34 ctc's. Dual Credit programs, nothing made it through, but the state is looking at the cost of dual credit, SBCTC is looking at giving OSPI additional funding to help. There is conversation also around summer running start sessions to help those students that are near completion to earn their degree at the same cost as if it were Fall to Spring. Senate Bill 5874, WSAC, residency affidavit updates.

**3:05 – 4:00pm Guided Pathways – What role are you playing at your college? What are you using for coding in ctcLink? If you're not using ctcLink, what are you using?**

Tacoma – Not necessarily using specific codes for tracking pathways yet, but are utilizing milestones, service indicators, student groups to help guide students in the enrollment/onboarding processes. Could see using similar methods as it comes to guided pathways. There is no standardized approach, which makes it difficult.

Spokane – Heavily involved in much of the discussion around guided pathways. Not doing much coding currently, but is in the process of working with instruction on program mapping.

Question came up about AARs...

Spokane – Starting over from scratch. Clark – Hired a 3<sup>rd</sup> party contractor, who's contract is almost up (CDW), Wenatchee – Talking to CDW about having someone from their team help build out.

Clark – Has been doing it for a while. They have mandatory advising. Program maps in their catalog. Have rebranded the guided pathways term as something different for students/staff/faculty.

Wenatchee – Doesn't know much. Registration hasn't been included in much of the conversation. It is faculty driven, and it sounds like things are not making progress like they hoped. Haven't seen any program maps.

Back to GP...

Wenatchee - Using student groups to track "pre" students, and hoping to use it for GP.

Clark – Is using student groups as well.

The Bio-Psycho-Social Model

The Better Moment Bookmark – Think about a time/place/event that you can go back to that brought you much joy.

Practice: Make this Moment Better

Oxygen Mask – Take care of yourself first – Nutrition, Activity, etc.

Living in the descriptive world and Leaving the judgmental world

“Humility is the Lens which we’re best able to see truth”

Judgement is something to consider – McDonalds lawsuit example “hot coffee”

Ride the wave of emotions – Awareness, Acceptance, Allowance

Notice your senses once again, and be aware of your emotions (give them a label)

Steps toward accurate expression – manage emotions, identify wants/goals, check situation, accurate expression

More of a statement... When Running Start students enroll in classes, they are charged tuition upon enrolling in classes, unlike in SMS, where tuition for RS students was adjusted immediately after a student enrolls in classes. Someone told me that it takes two business days for a particular state board process to run to recalc tuition based on the number of credits that a Running Start student is eligible for. However, before that happens, students see full tuition charges which creates confusion for many RS students when they register because they see these unexpected tuition charges. We'd like to suggest a solution to help alleviate these challenges: Communicate with state board the challenges that this is causing RS students as well as staff and to advocate for changing the tuition recalc process so that the tuition recalculation process occurs more frequently than every two business days, ideally we would want it to recalculate immediately, so that once a student enrolls in classes they see the correct balance. Communication, encouraging continuing conversations with RS students about possible limitations.
